

8. **Houses in Multiple Occupations**

As a result of issues with HiMOs in several estates which are contributing to lack of parking, fly tipping and anti-social behaviour and a lack of support to investigate from MKC, Cllr Whelan proposed that GLPC proactively engages with MKC Ward Cllrs to request a moratorium for a defined time on the acceptance of HiMOs within Milton Keynes. This was seconded by Cllr J Whelan and voted as all in favour.

This item will be carried forward as a recommendation to be ratified at the next Full Council meeting on 29th September 2021

Cllr Burgess suggested taking the matter to MKBALC and other Parish Councils.
